Invitation for Bids for procurement of Fabricated Steel Parts for Trail Bridges

1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Siddhicharan Municipality for **Trail Bridge Program** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
2. The Siddhicharan Municipality invites open bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

5. Bidding documents may be purchased from www.bolpatra.gov.np by eligible Bidders, on submission of upon payment of a non-refundable fee for bid documents as mentioned in the following table and bid document fee should be deposited in Siddhicharan Municipality, Okhaldhunga A/C No: **2070100301010003** Rastriya Banijaya Bank, Okhaldhunga until the (last date of purchase of bidding document) **(2078/10/07)** from the first date of publication of this notice.
6. Bids must be submitted through www.bolpatra.gov.np/egp, on or before **12:00 noon on 2078/11/08 (20th Feb 2022)**. Documents received after this deadline shall not be accepted.
7. Bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on **2078/11/08 (20th Feb 2022)** at the office of Siddhicharan Municipality, Okhaldhunga, Nepal. **Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security which shall be valid for 30 days beyond the bid validity period.**
8. If bidder wishes to submit the **Bid Security in the form of cash**, bidder has to **deposit cash in deposit account** at Rastriya Banijaya Bank, Okhaldhunga **Account No. 2070100303000003** Siddhicharan Municipality, Okhaldhunga and submit bank deposit voucher along with the bid.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
