1. *Shree Rajya Laxmi Secondary School, Siddhicharan Municipality-05, Sanitar, Okhaldhunga received a grant from Government of India towards the cost of "Construction of School Building of Shree Rajya Laxmi Secondary School, Siddhicharan Municipality-05, Sanitar, Okhaldhunga District, Koshi Province, Nepal"* and intends to apply part of the funds to cover eligible payments under the Contract for **"Works/RLSS/NCB/19/2081/82"**. Bidding is open to all eligible as per Section V of bidding document.

2. *Siddhicharan Municipality, Okhaldhunga* invites electronic bids from eligible bidders for the **"Construction of School Building of Shree Rajya Laxmi Secondary School, Siddhicharan Municipality-05, Sanitar, Okhaldhunga District, Koshi Province, Nepal"** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 5,15,60,000.00**
- Minimum Work experience of similar size and nature: **A RC Frame Structure Building Project within the last ten (10) years, with a value of at least NRs. 1,72,000,00.00 that have been successfully or are substantially completed**

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Siddhicharan Municipality, Okhaldhunga or may visit PPMO e-GP system www.bolpatra.gov.np/egp.

5. The Technical bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 PM 2082/02/06 BS (20 May 2025)** at the office of **Siddhicharan Municipality, Okhaldhunga**. Bids must be valid for a period of **90 (Ninety) Days** after the date fixed for bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid amounting to a minimum of NRs. **13,58,000.00**, which shall be valid for 30 days beyond the validity period of the bid. Bidders who choose to submit bid security amount in cash, should submit scan copy of Bank Deposit Voucher.
